CONDITIONS OF EX-SERVICE MEMBERSHIP

Eligibility

Two or more years' service, below commissioned rank (Commissioned Officers are unable to become full members of the Club), on the Active List of the Royal Navy, Army, Royal Marines, Royal Air Force, the Volunteer Reserve and Auxiliary Forces.

Candidates must produce clear evidence of satisfactory completion of service. Candidates must also clearly understand that, after election which is in fact reviewed annually, continued membership of the Club depends on acceptable standards of behaviour and conduct within the Club.

Individual/Family/Widow Membership

All candidates are subject to election by the General Committee and the approval of the Council.

Membership, is renewed annually, is subject to ratification by the General Committee and the Governing Council. Renewals will be made on the **1st January** each year, (without any application being necessary) unless before that date members have been notified to the contrary, or unless members have themselves given notice of their wish to discontinue membership. If payment has not been received by the end of February each year then your membership will automatically be cancelled.

Long Term Partners of Serving/Ex-Serving members will need to provide proof, such as photocopy of a joint Bank Account, or Mortgage, that they have been together for more than two years.

Family membership is for the serving or former member of the Armed Forces and spouse / long term partner. Children under 18 must be accompanied by one of their parents when staying the Club. Children over 18 may stay in the Club in accommodation paid for by a Family member.

Widow/Widowers membership is for former members spouse or long term partner.

All Members are subject to the Rules and Bye-Laws of the Club.

The decision of the Governing Council in any question is final.

Membership Cards

Each member and, spouse if Family membership requested, will be issued with a membership card, which must be shown when requested on entry to the Club. In the event of anyone other than the owner making use of this card, the owner's membership is liable to be cancelled.

Certificate of Service

It is our custom to return **original** Certificate of Services' by Recorded Delivery and, in view of the large number of applications we are now receiving, and the increased postal charges, we are finding it very expensive to continue this practice.

It would, therefore, be of great benefit to the Club if you would send us photo copies of your Certificate of Service with particular references to your **Length of Service** and conduct grading(s). As all Services Certificates are different the certificate will require the following details:
